TREASURER

Wolfgang Kuschinsky is currently Professor and Chairman at the Department of Physiology and Pathophysiology at the University of Heidelberg, Germany. Previously, he held positions as a Professor of Physiology at the Universities of Munich and Bonn. He has been trained as an MD and gathered research experience in the lab of Lou Sokoloff. He is a founding member of the Society and has served in the Editorial Board of its Journal from 1984 until 1992 and again since 2002. He has served in its Board of Directors from 1983 until 1987 and again from 1993 to 1997. He was Chairman of its Finance Committee



from 1999 until 2001. Since 2002 he is Treasurer of the Society. His major research interests include the regulation of cerebral blood flow during physiological and pathophysiological conditions, the microcirculation of the brain, the transport of nutrients to the brain and neuronal stem cells.
